At Un Buen Grupo de Amigos, we have reached an important milestone: we have obtained certification for our Anti-Bribery Management System (ABMS) under the ISO 37001:2016 standard for the first time. This recognition guarantees that the resources allocated to our humanitarian health and education programs are managed with transparency, integrity, and responsibility, reflecting the strength of our Integrated Management System (IMS) and the ethical commitment of our entire team.

For more than twenty years, we have worked with the conviction that humanitarian aid must be managed with honesty and sensitivity. Achieving this international certification confirms that we are on the right track and encourages us to continue strengthening our culture of integrity and social commitment.

We remain steadfast in our commitment to provide medical care to the most underserved communities through our Free Medical Care Days. This month, thanks to our dedication and collective effort, we achieved the following:

- 10 locations in 1 municipality in the state of Campeche
- 2 locations in 2 municipalities in the state of Morelos
- 12 locations in 2 municipalities in the state of Chiapas
- 4 locations in 1 municipality in the state of San Luis Potosí
- 3 locations in 1 municipality in the state of Veracruz
- 41 locations in 9 municipalities in the state of Puebla
- 40 locations in 10 municipalities in the state of Tabasco

Thanks to our teamwork, we provided assistance in family medicine, dentistry, nutrition, cancer screenings with mammograms, and health promotion workshops to help communities stay healthy.
